

RULES FOR THE STEF LOTTERY/TOMBOLA

Article 1: Organisation and purpose

The STEF CARES Association (an association governed by the French Law of 1901, under number: W691101286) is organising a lottery on its website. The lottery will begin on Friday 2 April 2021 at 6pm and end on Wednesday 14 April 2021 at 5:59pm, with the prize draw taking place on 14 April 2021 at 6pm. The winner will be announced after the draw on 14th April 2021 on the association's website and social networks.

Article 2: Participants and terms of participation

- 2.1. The lottery is open to all natural persons aged 18 or over.
- 2.2. Any person who wishes to take part in lottery must purchase one or more lottery "chance" tickets (costing €1 each). The maximum number of "chance" tickets per person is 100.
- 2.3. Participants can only buy tickets online, on the Stef Cares website.
- 2.4. Members of the Association's Board of Directors cannot participate in the lottery.
- 2.6. A participant wins the lottery if the number of the ticket he/she purchased is drawn.
- 2.7. Participation in the lottery implies that the participants have fully accepted these rules, with no restrictions or reservations.
- 2.8. Any person who fails to comply with the terms of participation set out in these rules shall be excluded from the lottery and their participation shall be deemed null and void.

Article 3: Prizes

- 3.1. The lottery shall award one prize:
 - 1 football shirt of the professional French football player Dayot Upamecano.
- 3.2. Once the draw is made, the result will be published on Stef Cares' social networks. Only one winner shall be designated from among all the participants and only one prize shall be awarded to the person designated as the winner. The winner will be notified by email or telephone. The name of the winner will be published on the STEF CARES Association's website. The prize will be sent to the winner by post (with acknowledgement of receipt) or by signed-for delivery, depending on the winner's geographical location.

Article 4: Prize draw

- 4.1 The prize will be awarded by a prize draw, which will take place via the Stef Cares website.
- 4.2 Only one prize will be awarded for the winning ticket.
- 4.3 The prize will be sent to the winner within one month of the draw. If the person does not collect the prize, he/she shall forfeit his/her right and shall lose ownership of the merchandise. The association will use the unclaimed prize for a future prize lottery.
- 4.4. By accepting the prize, the winner authorises the Association to use his/her last name, first name, as well as the photos and/or videos of the prize being awarded, if applicable, and the winner cannot lay claim to any rights other than the prize, including any image rights.

Article 5: Disclaimer

- 5.1. The Organiser cannot be held liable as regards the organisation of this lottery, and notably if, in the event of force majeure or events beyond its control, it is forced to cancel, shorten, extend or postpone the lottery.

5.2. Participating in the competition implies full and complete acceptance of these rules and any appendices. The prize offered may not be contested in any way, nor may it be exchanged for cash or any other item at the request of the winner.

5.3. The Organiser cannot be held responsible for any technical incidents that may prevent participants from connecting to the website once the winner is known.

5.4. The Organiser cannot be held responsible for the condition of the prize on delivery.

Article 6: Availability and consultation of the rules

6.1. The lottery rules can be obtained free of charge on the website of the Stef Cares Association at www.stefcares.org under the "lottery stef" heading.

Article 7: Personal data

7.1. Pursuant to the French Data Protection Act (No. 78-17) as amended, and the EU Regulation 2016/679 (GDPR), the Stef Cares Association is the data controller and shall be in charge of collecting the data of the lottery participants. These data notably include identification data (identifiers, contact details, etc.). These data shall be stored by the Association for a maximum period of five years, in accordance with the processing carried out.

The purpose of the data collection is to organise the lottery and to promote the social mission of the association. The processing is carried out on the data of participants who have consented to the use of their data in order to participate in the lottery.

7.2. Participants have the right to access, rectify and delete the information collected on any registration form concerning them.

Article 8: Disputes and claims

8.1. These rules are governed exclusively by French law.

8.2. The prize cannot be contested by any of the participants.

8.3. The winner cannot under any circumstances ask for the prize to be replaced by another, or demand reimbursement of the latter.
